Presentation of the BDDEC budget

Comptroller Gary McBride presented the BDDEC budget for 2023-24. Comptroller Gary McBride noted that the council is in sound financial standing and therefore will run a deficit for 2023-24. Comptroller

Gary McBride explained the three main pots of funding for BDDEC, which included Territorial Schools, Inclusive Schooling and Indigenous Languages. BDDEC has also received significant third party funding from JP/CFI over the past four years.

Comptroller Gary McBride spoke to issues of purchasing a truck with BDDEC funds. Comptroller McBride noted that we have accounted for the possibly of purchasing new trucks in the 2023-24 which should prevent BDDEC from undergoing similar issues it faced with the GNWT in 2022-23 over the purchasing of new trucks.

Jenna MacNeil - Inuvik DEA Chair - Question. What do we do with the budget after?

Superintendent Devin Roberts – We provide a copy of BDDEC Operating Plan and budget to the Department of Education Culture and Employment (GNWT). Chair Darlene Gruben emails the annual report and audited statements to the Minister of Education. Eventually the OP and budget go to the NWT Legislative Assembly. Later the Operating Plan becomes the annual report and is shared online for the public to see. BDDEC also posts our annual reports on the new BDDEC webpage at beaufortdeltadec.ca

Superintendent Devin Roberts –You as a council passed the budget last June, which allowed us to provide extra teachers in the school. We have also hired additional traveling teachers to support small schools. We cannot sustain this type of budget forever and therefore we have cut back the amount of PY's for 2023-24 compared to 2022-23. 193.97 PY compared to 217.12 PY.
